2.	The Changes, if any, regarding name of representative appearing in the list of provisional voters shall be sent to the Secretary General of the Women Chamber alongwith necessary proof of eligibility.	Monday 15 th July, 2024
3.	The Secretary General shall display the provisional list of all members eligible to vote alongwith their national tax, sale tax registration number if applicable with the name and national identity card number of their representative. (at notice board & web site of the Women Chamber).	Friday 19 July, 2024
4.	The members who have any objection to the entries/change on the list of provisional voters shall send their objections in writing to the Secretary General.	Monday 22 nd July, 2024
5.	The Secretary General will intimate action on the objection of changes sent by members.	Thursday 25 th July, 2024
6.	Any person aggrieved by the decision of the Secretary General may make a representation to the election commission.	Monday 29 th July, 2024
7.	The election commission shall decide the case.	Thursday 1 st August, 2024
8.	Any person aggrieved with the decision of the commission may appeal to the Regulator.	Monday 5 th August, 2024
9.	The REGULATOR shall decide the case whose decision in this regard shall be final.	Saturday 17 th August, 2024
10.	The final list of the voters shall be displayed at the notice board and at the website of the Women Chamber and also submit to REGULATOR.	Tuesday 20 th August, 2024
11.	Any person who is eligible to contest the Election for the vacant posts of the member executive committee shall send her nomination papers duly proposed, seconded by a duly registered voter and signed by the candidate, to the Secretary General on the prescribed form in accordance with the Article of Association or rules of the Women Chamber.	Thursday 22 nd August, 2024
12.	A copy of final list of voters shall be provided to each contesting candidate by the Secretary General.	Thursday 22 nd August, 2024
13.	Scrutiny of the nomination papers by the commission.	Thursday 22 nd August, 2024
14.	The list of nominees whose papers have been declared valid to be displayed on the notice board and the forms of withdrawal to the said nominees to be issued.	Saturday 24 th August, 2024
15.	The objection if any, to the nomination of candidates can be filed to the election commission.	Monday 26 th August, 2024
16.	The election commission shall decide the objections filed under the preceding clause.	Wednesday 28 th August, 2024
17.	Any candidate aggrieved by the decision of the election commission may file an appeal to the Regulator.	Saturday 31 st August, 2024
18.	The Regulator Trade Organizations shall decide the appeal referred under the preceding clause.	Thursday 5 th Sept, 2024

25.	Scrutiny of the nomination papers for the election of the office bearers by the Commission & display of contesting candidates on notice board.	Saturday 21 st Sept, 2024
26.	Polling for the election of office bearers.	Monday 23 rd Sept, 2024
27.	Incompliance with Trade Organizations Act 2013, Rule (19) and FWCCI Memorandum and Article of Association, Article 69, The final result of the election of members of the Executive Committee and office bearers shall be officially announced at the Annual General Meeting of the women Chamber called for this purpose.	(AGM) Saturday 28 th Sept, 2024
